Admission Policy and Procedure

1. About the Institute:

2. Seats Matrix for B. E. 2020

The seats will be filled in by following manner:

2.1 ACPC Seats (50%):

50% seat of the total sanctioned intake will be filled in by the Admission Committee for Professional Courses (ACPC, Government of Gujarat). These seats shall be filled-in by the candidates who have passed the qualifying examination from the schools located in the State of Gujarat and have appeared in GUJCET examination 2020. These seats shall be filled on the basis of ACPC merit list and as per the guidelines of ACPC. Candidate has to apply to ACPC separately. More details are available on <u>www.jacpcldce.ac.in</u>.



2.2 All India JEE Seats (35%):

35% seat of the total intake will be filled-in by Adani Institute of Infrastructure Engineering. These seats shall be filled from the candidates who have passed the qualifying examination from the schools located in India (including Gujarat State) and have appeared for JEE (Main) in January 2020 or likely to appear in July 2020 examination. Merit list for these seats shall be based on All India Rank of JEE (Main) 2020 examination.

2.3 NRI Quota Seats (15%):

15% NRI seats will be filled-in by Adani Institute of Infrastructure Engineering. The order of priority/preference for admission under NRI category will be as below.

- 2.3.1 **NRI Candidates:** Candidate who have passed the qualifying examination abroad. Such candidates are exempted from JEE (Main examination-2020) and the Merit list for these seats shall be based on the qualifying examination or
- 2.3.2 NRI Parent: Candidate whose either parent is staying abroad with valid visa (other than visitor or student) and have appeared in the JEE (Main) January 2020 or likely to appear in July 2020 examination and the Merit list for these seats shall be based on All India Rank of JEE (Main) 2020 examination.
- 2.3.3 **NRI Sponsored Candidates:** Candidate who have passed the qualifying examination from the school located in India (including Gujarat State) and sponsored by NRI. Such candidates must have appeared in the JEE (Main) January 2020 or likely to appear in July 2020 examination and the Merit list for these seats shall be based on All India Rank of JEE (Main) 2020 examination.

For NRI Quota, candidate has to apply to Adani Institute of Infrastructure Engineering in the prescribed application form (<u>www.aii.ac.in</u>)

2.4 Application for Admission to JEE and NRI Quota

For admission, candidate has to apply online to Adani Institute of Infrastructure Engineering through the link given in the institute website. (www.aii.ac.in/aiie/)

3. Eligibility for admission:

3.1 ACPC Quota (50%): As per ACPC Rules



3.2 All India JEE Quota (35%):

- 1. A candidate should have secured a rank in JEE (Main) 2020 AND
- 2. A candidate should have passed the Qualifying Examination with minimum 45% marks (40% in case of SC / ST) in aggregate in theory and practical of Physics, Chemistry, and Mathematics.

3.3 NRI Quota (15%):

3.3.1 NRI Candidates:

Candidate must have passed the qualifying examination abroad with minimum 45% marks (40% in case of SC / ST) in aggregate in theory and practical of Physics, Chemistry, and Mathematics.

3.3.2 NRI Parents & Sponsored Candidates:

A candidate should have secured a rank in JEE (Main) 2020

A candidate should have passed the Qualifying Examination with minimum 45% marks (40% in case of SC / ST) in aggregate in theory and practical of Physics, Chemistry, and Mathematics.

4. APPLICATION FOR ADMISSION:

- 4.1For admission, candidate has to apply online to Adani Institute of Infrastructure Engineering through the link given in the institute website. (www.aii.ac.in/aiie/.)
- 4.2 The Institute shall announce, by advertisement in some leading national newspapers / on web-site and by such other means, as it may consider necessary, the date of application, last date for submission of application form, programs offered and such other information as may be necessary in this regard.
- 4.3 For the purpose of application, a candidate shall be required to make payment of Rs. 413/- (inclusive of 18% GST) through online.

5. Admission Procedure:

The admission procedure shall be in the following manner:

- 5.1 The Institute shall prepare the merit list of the eligible candidates who have applied for admission under All India JEE Quota and NRI Quota.
- 5.2 The candidates will have to check their inter-se merit number on the Institute website.
- 5.3 The admission shall be offered through On Campus counseling as per the schedule and no individual communication will be made in this regard.
- 5.4 The candidates shall be required to appear in person on the allotted date/schedule and have to register at least one hour before the prescribed schedule at the registration desk of BE Admission for

campus counselling process. The candidates shall make their own arrangements for reaching the Institute campus. In case of serious illness/accident or other unavoidable circumstances, where candidate cannot attend the counselling, his/her guardian may remain present on his behalf with a request cum-authorization letter written by the candidate with all the required original documents.

- 5.5 A candidate who remains absent at the On Campus Counselling Process as per the schedule will not be considered for that round of the admission process.
- 5.6 Offer of admission shall be made on the basis of merit and availability of the seats at the time of counselling.
- 5.7 Counselling will include verification of the original documents, personal and academic credentials of the candidates viz. identity, age, academic qualifications and thereafter the admission will be offered to the eligible candidates, as the case may be. The candidates are required to produce any other certificate/s as it is deemed necessary.
- 5.8 The candidate who has been offered admission shall require to pay the fees immediately, as prescribed herein to get his/her admission at the time of on campus counselling process. A candidate who fails to make payment at the time of counselling shall not be considered for that round of the Admission
- 5.9 A candidate reporting late for On Campus Counselling Process may be accommodated in any of the remaining admission counselling sessions as per the on-going merit, if possible. However, this shall not be obligatory on the part of the Institute. The Institutes' decision shall be final and binding in this regard.

6. Fees :

- 6.1 A candidate has to pay the total fee as prescribed herein, at the time of offer of admission through a NEFT/RTGS/PAYTM/Demand Draft drawn in favor of Adani Institute of Infrastructure Engineering, payable at Ahmedabad. No extension of time shall be granted for paying the fees.
- 6.2 Fees for All India JEE Quota candidates: INR 82,500* (semester fees) <u>* Subject to upward revision after the final approval from FRC</u>
- 6.3 Fees for NRI/NRI Sponsored Quota candidates:

8. Cancellation of Admission offer:

During verification of documents or subsequently, if the Institute finds that any certificate or testimonial or information submitted by any candidate is incorrect or false or irrelevant/non-compliant to the requirement, the admission of such candidate shall be cancelled and he shall be permanently disqualified for admission at the Institute.



9. Refund for Cancellation of Admission:

- 9.1 Cancellation of admission by the candidate or his guardian or authorized representative:
- 9.2 If a candidate applies for cancellation of his admission through email/in-person the fees paid shall be refunded after deduction of Rs. 1000/- as administrative charges, provided such vacated seat gets filled up.
- 9.3 The refund will be made only after 31 December 2020 after receiving all required documents from the candidate in this regard.
- 9.4 In case of a candidate who has already secured admission on All India Seats in a branch and later on secures admission through ACPC in any other branch at this Institute, the admission given on All India Seat for such candidate will stand cancelled. In such case the fees paid for All India Seat will be refunded after deducting Rs. 1000/provided the All India seat vacated by the candidate gets filled up by another candidate.
- 9.5 In case of a candidate who has already secured admission in a branch at the Institute through ACPC, and later on secures admission on All India Seats in any other branch, the candidate has to make the payment of full fees as prescribed for all India seat admission. Such candidate has to make sure for cancelling his admission at ACPC immediately; it shall be the responsibility of the candidate to provide proof of the same to the Institute; and to process for the fee refund as per the ACPC rules.
- 9.6 If a candidate admitted on NRI seat, gets admission on All India seat/ACPC seat, his fees paid up on NRI seat will be adjusted against the fees of All India/ACPC seat, and the balance amount will be refunded on 31 December 2020 provided the vacated NRI seat by him/her gets filled up by another NRI sponsored quota students.
- 9.7 The candidate shall be required to submit request of cancellation of admission in the prescribed form along with the original receipt of the fees paid.

10. Hostel:

Institute facilitates for hostel accommodation to the admitted students through reputed accommodation providers near the campus long with to and fro transportation facility. Candidate can acquired more details from Admission office in this regard.



11. Interpretation:

In the matter of interpretation of Admission Policy and Procedure, if any difficulty or question arises as to the interpretation of any provision or such issues which are not covered here, the decision of the Director, Adani Institute of Infrastructure Engineering will be final. The candidates will be bound by the rules and regulations of the Institute as applicable during their course of study at the Institute.
